### Awards:

Allied Academies recognizes the commitment and astonishing work in all academic and research fields. By honoring their contribution; by awarding the Best YRF and Researcher Awards in all academic disciplines and categories along with other similar awards, we encourage and empower scholars, researchers and academics; and other gifts, such awards include prestigious Certificate of Recognition.

### OCM Awards

The organizing committee should make use of the various tasks to be performed in the course of handling them. Members of the Committee, having a strong erudition of the event management strategy, are well positioned to provide instruction, guidance and assistance to all staff participating in the event organization. Allied Academies will recognize the person who has demonstrated their support and encouragement during the conference as the best OCM. OCM, including Dean, Professor, HOD, Chairpersons, CEO, CFO, MD etc. should be esteemed or strongly affiliated. Selection of the best OCM will be made based on the participation of the participants and years of experience in the respective field of study. They must have a good number of research papers and citations, and more years of experience should be needed.

### Keynote Speaker Awards

Biochemistry-2020 chooses a suitable keynote speaker to speak at the meeting. Both approved ideas for keynote speakers will be eligible for the Best Keynote Speaker Award. Among the approved proposals the committee will pick a number of candidates for the prize. At the meeting the winner will be chosen taking into account both the plan and the presentation. Best keynote speaker will help raise morale, change their way of thinking, and enliven and encourage audiences. The person should be eminent or highly associated for Keynote such as Dean, Professor, HOD, Chairpersons, CEO, CFO, MD etc. The selection of the Best Keynote Speaker will be made based on the participation of the participants and years of experience in the respective field of study. Each submission is approved based on abstract content and the theme of the conference. Irrelevant submissions will be rejected. The Organizing Committee will select the acceptance and rejection of abstract submissions. Both submissions pass a quality test. The final approved abstract for Keynote award will be considered.

### Best Speaker Awards

Biochemistry-2020 believes our best speaker to be recognised. The best speaker is selected prior to the conference according to their research abstract. A selection panel is used to determine all winners. This award is designed to recognize and identify outstanding speakers who have attained extraordinary eminence and success in recent years. Being an outstanding speaker means delivering a message which involves an audience. The outstanding presenter award will be given on the basis of presentation organization and professionalism, presenter communication skills and appropriate time utilization. Each session is measured separately. The person should be Professor, Researcher, Scientist, Entrepreneur etc. for speaker.

The selection of the speaker shall be made on the basis of the participation of the participants in the respective field of study. Every submission is approved based on the content of the abstract sessions and conferences. The Organizing Committee shall pick the acceptance and rejection of the abstract submissions. All submissions will be undergoing a quality assurance process by our department. Final approved abstract will be considered for exceptional speaker award.

### Young Research Forum Awards:

Biochemistry-2020 offers young researchers an incentive in various conference fields. Until the conference the best participants are chosen according to their research abstract. If you're a creative young researcher then you can join our conferences to discuss new ideas and science. The best YRF is selected by a panel of judges. At the end of the conference the Strongest YRF will be publicly recognized. The Best Young Research Forum Award will be awarded to the most outstanding presentation by a participant who has enrolled under the category of student. Undergraduates, Master's and Ph.D. students are considered in this category. The selection of the YRF will be made based on the participation of the participants in the respective research area, and each application will be approved based on the conference sessions. Rejecting insignificant requests. The committee will select the approval and rejection of abstract submissions. Both submissions pass a quality test. YRF award will be considered for final authorized abstract.

### Best Poster Awards:

To be eligible for the award Students interested in getting their

posters considered for the Biochemistry-2020 conference have to apply to the conference an overview of their poster. The award committee should consider all posters relevant to the public opinion report, whether they concentrate on theory, analytical results, and methods of analysis and/or methodological techniques used in such analysis. Both posters will be automatically eligible for the Poster Award, and the posters will be displayed at the conference site, and the best poster judges will be chosen. The winners are officially named at the closing ceremony. The winners will be awarded a Certificate.
